III OLD BUSINESS

- B. Status of Request to Restrict Parking in 600 Block Grace Street – denied by City  
Moved by Kelly, seconded Runyon; Talk to Chief of Police regarding parking enforcement and plans for making contact with the police department on July 4th - carried
- C. Membership
  - a. Status - 18 new and renewing members
